

Kalenborn increases capital, reorganises management

With immediate effect the share capital of Kalenborn Group, the wear-protection systems specialist based in Vettelschoss, Germany, has been increased by the management partners from €3M to €4M to strengthen the company's further development. At the beginning of January Dietmar Tremmer withdrew from the management board after 10 years with the company.
